HFMD IS ACCEPTING NOMINATION APPLICATIONS FOR THE



The CSL Behring program, **Getting' in the Gamesm Junior National Championship** was the first national sporting competition designed specifically for the bleeding disorders community. The program gives children with bleeding disorders an opportunity to compete in baseball, basketball, golf or swimming and provides education and information-sharing opportunities for participants and their parents/caregivers.

Who is eligible: Children between 7–18 years of age with a bleeding disorder (nominees must be accompanied by a caregiver 25 years of age or older at the event. Due to state and federal laws, CSL is unable to permit healthcare professionals to attend.) Special consideration will be given to first time attendees, but all children who have attended in the past are welcome to apply again!

Cost: Free! CSL Behring will sponsor two chapter nominees and one accompanying caregiver for each nominee to participate in the program. This sponsorship will include the coordination and cost of airfare, ground transportation in Henderson, Nevada, and hotel arrangements *(attendees will be responsible for transportation to/from their hometown airport).*

*This event is limited to the nominee and one caregiver only. CSL is unable to accommodate additional family members at any JNC related events.

During the program nominees will have the opportunity to:

- Take part in baseball, basketball, golf, or swimming activities to learn the fundamentals and enhance their skills in that sport.
- Learn about the importance of physical fitness and managing a bleeding disorder and receive instructions on proper stretching techniques and good athletic form.
- Show off their ability in the national competition with fellow nominees from around the country.
- Connect and build relationships with fellow members of the bleeding disorders community by sharing their personal experiences with one another.

Annual Meeting, April 19-20, 2024

The buffet dinner was opened at 5:30 and while meals were enjoyed, we entertained by one of our very own community members, the lovely and talented Annelise Carlson.

Annelise drew curiosity, awe, and wonder with her musical talent. When I asked for background on her musical journey, mom, Lydia shared: "She plays an instrument called the guzheng, or Chinese Zither. The instrument is a Chinese traditional instrument several thousand years old (she plays a modern one, but the instrument has been around that long). Annelise has studied the instrument for 6 years with a teacher here in Minnesota and another teacher in Arizona. She has competed in a number of international competitions and has won top prizes including one on Chinese TV, another in Shenzhen, China, and one in Hong Kong."

We hope Annelise will be back to perform for us again in the near future!

After dinner the HFMD group hit the bowling lanes. We reserved 6 lanes from 6:30-8:30. We broke this into two 1-hour bowling sessions. When Members check in at the registration table, they sign up for the preferred bowling session.

SATURDAY, APRIL 20th:

Teens were encouraged to stay for this part of the session, as it is important that they learn to advocate for themselves, as well as others. Members looked up the number to their

local state representative, calls were made and messages left asking the representatives to support these three bills:

- Full Funding for Rare Disease Advisory Council HF 3841
- Medical Bill Debt Relief HF 4100
- Prior Authorization Reform Bill HF 3578.



After this important opening Group Action, Amy Wilson, MSW, LICSW, ACM, from M Health Fairview presented on Mental Health and Wellness. There interactive stations that provided helpful suggestions on what one can do to help with their own mental health and wellness. These stations were a big hit and they included affirmation cards, aromatherapy, journaling, acupressure and more.



After the health and wellness presentation our group had a break to spend time with exhibitors and check out of their hotel rooms.

The day proceeded with Miranda Solem from BDSUMHAC (Bleeding Disorder Substance Use and Mental Health Access Coalition) speaking on

the issues that affect and surround access to substance abuse and mental health programs for those who have a bleeding disorder and the policy intervention areas when there is a treatment facility denial.

After the break for lunch, the afternoon started with Jeff Amond, from Hemophilia Alliance giving us helpful information on Navigating Health Insurance. Jeff spoke on how to navigate the common problems that arise with health insurance companies while trying to treat your bleeding disorder.

For the adults, the event wrapped up with a fun and exciting game of Hemophilia Jeopardy. Melinda Otto and Dawn Rusk from Mayo Clinic in Rochester hosted this

competitive and fun game of bleeding disorder information based game. Prizes were given to members at the winning table.

While the adults were playing Hemophilia Jeopardy, the teens *(including all the children in the children's program)* went to the arcade to enjoy an hour of unlimited games. This event concluded the Annual Meeting, goodbyes were said and the group adjourned.
